



Terms of Reference External experts to develop the Curriculum for work with youth at risk

Background

The "No risk, no borders for young people" project is coordinated by the Drug Policy Network South East Europe (DPNSEE) together with the project partners Aksion Plus (Albania), Margina (Bosnia Herzegovina), Juventas (Montenegro), Prevent and Re Generation (Serbia) and supported by the Regional Youth Cooperation Office (RYCO) within its 4th Open Call co-financed by the European Union.

DPNSEE and its partners designed this particular project proposal that directly addresses following main issues/problems:

- Present and increasing stigmatization of the marginalized youth groups targeted by the project – youth at risk (young people who use drugs, youth in conflict with the law and youth with alternative lifestyles and identities: sex workers, LGBTI people, young people in conflict with the law, and others), as also lack of the visibility and mutual understanding of their needs;
- Lack of the regional youth cooperation on the issue of the targeted marginalized youth groups; and
- Lack of the active youth participation and leadership in CSOs.

Additional important project's effort is to address opportunities for regional youth cooperation focused on youth at risk, despite the COVID-19 pandemic and its obstacles.

The project is strongly focused on marginalized youth groups that are in our context defined as youth at risk consisting of young people who use drugs, sex workers, LGBTI people, youth in conflict with the law and others addressed as "youth with alternative lifestyles and identities".

Project activities included:

- Pre-task activity Selected activists/workers conducted pre-task activities to investigate and document cases of discrimination in their communities (communities of marginalizes groups)
- 4-days Workshop 1 on "why" (the situation of marginalized youth) and "what" (services to help them)
- Follow-up activities Activities with youth at risk, with continuous support and supervision to test tools and methodologies. Activities included cross-border exchange programme.

Objectives of the ToR

To develop the regional Curriculum focused on work with the youth at risk.

We understand that curriculum is a standards-based sequence of planned experiences to effectively support learning.

Outcome of the consultancy should include:

- Goals (expectations for learning), methods (approaches, procedures, and routines) and assessments (gathering information about students' learning) of the whole learning experience (both training opportunities and practical work to put learning into practice)
- List of modules which constitute the training
- Aims, objectives, methods, materials and assessments to deliver the modules and evaluate learners' progress

The Curriculum should provide a comprehensive educational approach, fully based on principle "youth for youth". It should be developed using the technical knowledge presented through the workshops and practical skills offered through the pre-task activity and follow-up activities of the "No risk, no borders for young people" project, desk researches on the issues covered by the Curriculum and the expertise of the external experts.

Enclosed are the agendas for two workshops held during the project. DPNSEE will provide training notes, presentations and other training materials for the session to the experts engaged to produce the Curriculum.

Structured approach to capacity building, defined by the Curriculum, should increase involvement of the CSOs, youth workers and volunteers in solving issues and fulfilling the needs of youth at risk.
