



In 2019-2021 three training sessions for about 200 decision-makers on national and local levels across Ukraine from different sectors of governance



Strategic goal 1. Promotion of a healthy lifestyle, reducing the demand for psychoactive substances

Strategic goal 2. Narcotic drugs, psychotropic substances and precursors illicit trafficking counteracting, reducing illicit drugs and substances supply and their timely seizure

Strategic goal 3. Ensuring the availability of narcotic drugs for those in need

Strategic goal 4. Timely and quality assistance to people with mental and behavioural disorders due to the use of psychoactive substances, and the availability of comprehensive harm reduction services



Strategic goal 1. Promotion of a healthy lifestyle, reducing the demand for psychoactive substances.

- Operational goal 1. Psychoactive substances use prevention
- OG 2. Secondary drug abuse/dependence prevention among PWUD



SG 2. Narcotic drugs, psychotropic substances and precursors illicit trafficking counteracting, reducing illicit drugs and substances supply and their timely seizure.

OG1. Reduce the number of psychoactive substances available on the illegal market.

OG2. Prevent the leakage of narcotic drugs through the implementation of effective measures of state regulation and control.

OG3. Prevention of use of an analogues or new psychoactive substances.

OG4. Strengthening the human resources of law enforcement agencies.



# Strategic goal 3. Ensuring the availability of narcotic drugs for those in need.

# OG1. To provide access to treatment with the use of narcotic drugs.

OG2. Promoting the development of palliative care.



SG4. Timely and quality assistance to people with mental and behavioural disorders due to the use of psychoactive substances, and the availability of comprehensive harm reduction services

OG1. Provide diagnostics, medical and socio-psychological care, rehabilitation and resocialization for persons with mental and behavioural disorders due to drugs use and ensuring access to harm reduction programmes.

**OG2**. Improvement of the treatment system composition and provision by **decriminalization**, **reduction of stigma and discrimination**, and introduction of **alternatives to imprisonment**.



## SG4. continuation

# OG3. Introduction of the substance disorders treatment in prisons.

**OG4. Set up effective** epidemiological surveillance of the prevalence of psychoactive substance use and effective M&E of the effectiveness of state drug policy implementation.
